#### Main discussion points - decisions

#### Introduction of MediciNet II project partners.

In the beginning of the project meeting, Mr Panagiotis Michailidis, MediciNet II Project Manager welcomed all the attendees and thanked especially the Bulgarian delegation for their participation to the meeting but also in the opening press-conference held right before the meeting. At that point, he invited Mr Georgios Filippidis, CEO of the General Hospital of Komotini "Sismanogleio" to make a short welcome speech.

Mr Georgios Filippidis also thanked the Bulgarian delegation for attending both the meeting and the press-conference that practically marks the official launch of the MediciNet II Project. He also highlighted the importance of the MediciNet II Project for the General Hospital of Komotini "Sismanogleio" as well as his certainty that it will be one more successful project as it was the first one, thanks to the effective and efficient cooperation between the two hospitals. Finally, in this occasion, he offered to the BoD representative of the MHAT "Dr. Atanas Dafovski" AD a basket with Rhodope's local products.

Mr Spas Pasev expressed also his gratitude for the warm welcome and hospitality, wished every success for the

meeting as well as for MediciNet II project as well and invited the Greek representatives at Kardzhali in the occasion of the forthcoming events to be organized there.

At last, Mr Panagiotis Michailidis (MediciNet II Project Manager) invited all the attendees to introduce themselves briefly stating their names and working positions as well as the way they will be involved in the project.

Immediately after the introduction part was completed, the meeting's main discussion topics were briefly presented and attendees were asked whether they would like any other topic to be added in the agenda. Nobody had to add a new topic.

MediciNet II project overview: concept, objectives, WPs & main outputs, expected results.

During this session, LB representatives presented the main data related to the project, stating that given that the LB signed the Subsidy Contact dated as from 01.09.2017, the end date of the project is on 31.08.2019.

Making a quick review in the project history in connection also with the "first" MediciNet project implemented within the previous programming period, LB representatives were referred to the evaluation, selection and presentation of the MediciNet project as a best practice ETC project in May 2014, while that first project's implementation ended on June 2014, celebrating its successful implementation with the signing of a Memorandum of Understanding between the two hospitals.

Afterwards, the second joint project proposal (MediciNet II) was drafted and submitted for funding within the 2<sup>nd</sup> Call for Project Proposals of the Cooperation Programme INTERREG V-**A "Greece**-Bulgaria 2014-**2020"**, while one year later, the two hospitals were informed about the MediciNet II project approval with the highest score within Investment Priority 9a.

Right after, a negotiation period between the two hospitals and the Joint Secretariat of the Programme started, aiming to the revision and the finalization of the MediciNet II project budget. The negotiation resulted to an 11% reduction of the budget initially requested by both partners. At that point, it was also further commented by LB representatives that specific project deliverables were eliminated (DIv. 4.1.1. Healthcare mobility app for LB only), although their intention is to use (if possible) amounts coming from possible savings in order to implement this deliverable as well. However, this is an issue that it will be discussed again during the project lifetime, as soon as the various contracting procedures will be finalized.

In addition, within this session, LB representatives presented the overall and the specific objectives of the project, highlighting that vulnerable groups such as people with disabilities, poor and children, as well as groups exhibiting high incidence of health problems and high CB mobility such as Roma, will also benefit from the increased efficiency and effectiveness of the public health services provided.

Speaking for the project main results, these were summarized to the following ones:

- Upgrade of the Operating Rooms of GH of Komotini installation of a fully equipped ready for operation Surgery block of four (4) surgical rooms.
- Supply of special medical equipment related to intensive and emergency care in the MBAL Hospital Kardzhali.
- Development of a WEB/mobile device application by the MBAL Hospital Kardzhali that will enable GPs in remote areas access to patient electronic medical records stored in the hospital HIS administrative, demographic, and clinical information, family history, problems (diagnoses), allergies, medications, vital signs/physiological measurements, lab results/observations, X-RAYS, CTs, discharge documents etc.
- Organization of a series of training activities, including cross-border study visits and joint master-classes for at least 40 doctors and other medical staff.

Moreover, commenting the budget allocated per Work Package, all agreed that most of the efforts should be given for the immediate launch of the WP3 activities (procurement of medical equipment) where the major part of the budget is allocated for both of the partners.

Also, an interesting aspect of the new MediciNet is that the project involves activities not only to be implemented within the hospitals' structures but also all over the two intervention areas (Rhodope & Kardzhali).

In the end of this session, Mr Panagiotis Michailidis shared his experience gained within the implementation of the "first" MediciNet Project and highlighted two important "lessons learned" encouraging attendees to work together closely and ensure:

- Faster and more accurate communication response (e.g. setting a goal of immediate response within 1 day, response within 8hours in the emails highly prioritized)
- Development of common terms of reference or activities' content as soon as the project starts, in case of common outputs

PB2 representatives confirmed their willingness to improve internal communication in terms of time and content, while they also asked to receive any informational material already designed, in order the homogeneity of the project material to be ensured.

**Presentation of project's overall working plan. Roles and Responsib**ilities per partner. Actions. Deliverables. Timetable. Milestones.

LB representatives presented the project's working plan in a series of slides analyzing each work package and deliverable separately, with emphasis on the role of each partner (coordination/ contribution) and the defined timetable (start and end date). In particular cases, the content of specific deliverables was further analyzed.

Partners had a great interest to exchange ideas concerning the main topics and the content of the training activities for the medical staff (within WP5) in order to develop a joint training program both at cross-border as well as at local level. Therefore, they agreed to dedicate a whole session on this topic within the next (2<sup>nd</sup> Project Meeting). In addition, PB2 representatives informed LB that they have already proceeded to a preliminary mapping on medical staff's training needs and they proposed to send this material for further elaboration by LB.

Within this session also, partners made a review of their achievements comparing to the Start-Up Plan they had presented to the JS in the beginning of the project (including tasks to be accomplished by the end of March 2018). As a general conclusion, by the moment of the meeting, 50% of the STPP activities have been completed, while the deviations from the initial planning are very limited.

#### Action plan for the first semester 2018.

Within this session, Mr Panagiotis Michailidis (MediciNet II Project Manager) presented LB's proposal with regards to the Action Plan and the milestones set for the 1<sup>st</sup> Semester of 2018 as it follows:

WP1/ D.1.1.2 & D.1.2.1 (19.01.2018): Submission of the 1<sup>st</sup> Progress Report. LB is in charge to prepare and submit the Progress Report, while PB2 was requested to provide info with regards to the project progress so far and the payments executed (if any).

At this point, PB2 representatives provided some preliminary info concerning the progress so far, informing attendees that no expenses were incurred up to the end of December 2017, although three contracts were signed up to then (1. management & coordination, 2. events' organization and 3. communication & dissemination material production).

As far as the procurement procedure for the medical equipment is concerned, their time plan includes the publication of the relative tender in the end of January 2018, expecting to complete procurement, contracting and delivery procedures by the end of June 2018 (payment of the contractor as well). Following this strict time plan will help them to pay back the loan that they will receive in order to cover the full cost of the equipment (since except for a part of EU financing, there is no pre-financing for the Bulgarian partners in this particular Program). LB representatives expressed their concerned about the time and complexity of the process required for the approval a loan by the Bulgarian banks based on their common previous experiences. However, PB2 representatives explained that the process has been simplified thanks to legislative changes that enables the hospital to have a direct contract with the bank of their choice, without a procurement procedure to be required.

WP2/ D.2.1.1 (31.01.2018): Information and Publicity Handbook (LB)

WP2/ D.2.1.2 (31.01.2018): Design & Production of card-postals (LB)

WP2/ D.2.2.1 (28.02.2018): Prepare communication and dissemination material (PB2)

WP2/ D.2.2.2 (16.02.2018): Opening Press Conference at Kardzhali

LB representatives expressed their willingness to participate to the press-conference at Kardzhali, therefore they asked PB2 to communicate the event's date the soonest the possible. LB representatives also advised PB2 to prepare some of the project information material in advanced in order to disseminate it in the occasion of the press conference. They both agreed that LB should send the material already designed in order both partners to follow the same designing context.

WP2/ D.2.1.4 (31.03.2018): Project's website update (<u>www.medicinet.eu</u>) (LB-PB2)

Mr Panagiotis Michailidis (MediciNet II Project Manager) asked kindly for the immediate response of PB2 for the provision of texts and other material, as well as translations in Bulgarian required for the website, in order at the end of March to be fully updated and operational.

WP3/ D.3.1.1 (28/02/2018): Procurement of Komotini's Hospital Medical Equipment (LB)

Finally, PB2 expressed the need for a modification concerning the items to be procured (equipment) within WP3 before proceeding to the tender publication. They explained that since the submission of the project proposal, specific items have already been purchased by the hospital, therefore they have to be replaced by other — also necessary based on the hospital's current needs. There will be any change affecting the total budget or the budget allocation among the WPs or the various budget lines. Moreover they also informed the Project Office (Mrs Jenya Dinkova) for this request and she encouraged them to proceed. Mr Panagiotis Michailidis - speaking for the General Hospital of Komotini "Sismanogleio" informed PB2 that they also face a similar case. The two partners agreed to prepare and submit the modification request in the beginning of February.

Presentation of the project communication strategy and target groups to address.

LB external experts presented briefly the project's communication strategy in compliance with the overall Program Communication Strategy, while they were particularly referred to the common rules to follow accordingly to the **Program's Inform**ation & Publicity Manual.

Starting with the project's communication strategy, is reflected on the following general communication objectives:

- 1. Raise public awareness of the MediciNet II project, its activities and its potential benefits in the cross-border area.
  - Strengthening the interest of stakeholders and institutional partners in implementing the project as a key tool for the benefit of the region.
  - Informing the public about the results and benefits of the project.
  - Creating a positive climate for project acceptance and mobilization of target groups, aiming to increase their participation in interventions and project actions.
- 2. Promote the role of the European Union and ensure transparency regarding public funding.
  - Presentation of the funding coming from European funds in the project and emphasis on the added value attributed to the community.
  - Transparency about how and how European Union money is spent, as well as the specific benefits of project actions.

In addition within the project's specific objectives are included:

- With regards to awareness raising (i) Promotion of the project and its role in the Greek-Bulgarian cross-border area of and (ii) Promotion of the benefits for the citizens of the cross-border area as a result of the implementation of the project
- With regards to the promotion of the role of the European Union (i) Promoting the role of EU funding in the daily problems of citizens and (ii) Recognizing the contribution of the MediciNet II project at the

level of primary health care and emergency care services provided

Therefore, LB external experts further explained that the communication strategy will

- promote the project activities and results to the public and the stakeholders;
- provide sufficient information for the project and its benefits for the border populations;
- highlight the project impact in the fields of public health, health care services, cross-border cooperation etc. resulting to the improvement of the living standards of the local population
- create channels of cooperation between the involved stakeholders in the region,
- mitigate the negative impact that borders may have on the quality of life,
- emphasize the short, medium and long-term effects related to the project implementation

In addition, the main target groups within the project were presented as it follows:

- Stakeholders involved in the primary health care and emergency care services at local, regional and national level.
- Representatives of all local, regional and national authorities in the cross-border area.
- Local, regional, national, European, but also thematic Media.
- The staff of the two partners.
- The general public.

Following, the general communication framework of the Program was present including its main concept for the period 2014-2020, the unified visual ID for all the projects depending their project's thematic objective, the main characteristics of the Program logo to be respected by all the program beneficiaries etc.

In addition, LB representatives informed PB2 that they requested the use of the "first" MediciNet logo in the frame of the new unified (for all the projects) visual ID and this request was approved. Moreover, the new graphic art designs especially for MediciNet II, instead of partner logos, use for partner identification the hospitals by themselves. This modern transition is expected to increase project recognition within and out of the local community. Graphic art design templates for folders, brochures, notebooks and pens were also presented.

By the end of this session, the two partners organizations agreed on the issues below:

- It is imperative that both partners use the same elements of communication and visual ID at all times.
- When creating a communication material, each partner shall consult our joint communication base for:
  - Project logo and graphic elements
  - EU and ERDF references to all communication material
  - Fonts, sizes and textual references
- It is strongly suggested that P2 shall receive guidance for MediciNet II visual ID and graphic elements (logos, templates, colours, photographs etc.)
- Before producing any material and prior to sending it to the Joint Secretariat, we P2 should notify LB with each designed material.

### Partners tasks related to the project management & reporting.

The aim of this session was the summary of the main obligations and tasks of the both partners related to the project management and coordination based on the program's documents, the subsidy contract, the partnership agreement as well as the project management procedures described in the Application Form. LB experts in charge to present this session focused on the reporting, payment/ cash flow and modification procedures.

Scheduling of the next project meeting.

According the project application form & justification of budget form, the 2<sup>nd</sup> project meeting is planned to be organized at Kardzhali. Partners agreed to organize it within the last week of May or the first week of June (28 May to 8 June 2018) and decide for the exact date upon their availability in the end of April/ beginning of May. PB2 will be responsible to propose alternative dates in order the two partners two decide together. The meeting agenda will be prepared by LB and validated by PB2.

## Specific objectives:

- Maximize the effectiveness of the health and medical sources of the two hospitals, providing advanced services to a greater number of medical cases and citizens.
- Minimize the need of patients' transfer in cases of emergencies, thanks to the new improved medical facilities to be placed in the two hospitals, as well as the Healthcare Mobility Software to be applied by PB2, especially serving people living in remote and isolated areas of Bulgaria.
- Strengthen the exchange of know-how and the cooperation among the medical staff of the cross-border area, focusing especially in joint emergencies' management.

- Upgrade of the Operating Rooms of GH of Komotini installation of a fully equipped ready for operation Surgery block of four (4) surgical rooms.
- Supply of special medical equipment related to intensive and emergency care in the MBAL Hospital Kardzhali.




# Reporting procedures

Considering that contracting procedures are completed, it is important that the main steps of reporting procedures are discussed:

- Reports will be submitted **electronically**, though the portal is not ready to use yet
- LB submits the progress reports to the JS
- Reporting periods are **January-June** and **July-December**
- Deadline for submission is **max. 20 days** after the end of the period
- Once verified, expenditure certificates can be sent to the JS at any time

# **Modifications**

Three levels of project changes, based on the impact on project structure. These are categorised:

- 1) Modifications by the Beneficiaries with notification of the JS/MA
- 2) Modifications approved by the Managing Authority (MA)
- 3) Modifications approved by the Monitoring Committee



# Modifications by the Beneficiaries with notification of the JS/MA

# Examples are:

- 1) Administrative Information in the Application form
- 2) Modification of bank accounts
- Adjustment of the justification of budget cost that does not affect the scope of the project or any information in the Application form
- 4) Adjustment of starting and ending dates of work packages without affecting the overall end date of the project
- 5) Small and simple adjustments (<10% of total budget) between WPs and cost categories without affecting the scope



# Modifications approved by the Managing Authority (MA)

### Certain examples:

- Budget reallocation between WPs and cost categories for up to 20%
- 2) Budget reallocation (<10%) of beneficiaries from the same country
- 3) Extension of the date set for closing project implementation activities




# **Modifications approved by the Monitoring Committee**

#### Certain examples:

- 1) Budget reallocation between actions and cost categories greater than 20%
- 2) Large Budget reallocation (>10%) of beneficiaries from the same country or any reallocation between partners from different countries
- Changes to the nature of the project and in particular to the objectives and the expected results (duly justified)
- 4) Modification to the composition of the partnership (duly justified)
- 5) Budget modifications decided by the Monitoring Committee on the basis of sound financial management of the Programme
- 6) Addition of new activities
